- 用語の説明：
- 1 取下とは、保存義務者が承認申請を撤回したものをいう。
 - 2 却下とは、承認申請の要件を欠いているため審査の対象にならないと判定されたもの及び審査の結果、申請が承認されなかったものをいう。
 - 3 取りやめとは、保存義務者の申し出により、電磁的記録等による保存をやめたものをいう。
 - 4 取消とは、承認の取消しをしたものをいう。

Subject of survey: "Requests for approvals" based on Law (or Act) on Book and Record Keeping through Electronic Methods from July 1, of each year to June 30, of the following year.

- Terminology:
- 1 "Withdrawals" mean requests canceled by those who shall keep books and records.
 - 2 "Dismissals" mean requests rejected due to the lack of requirements and unapproved as a result of administrative inspection.
 - 3 "Cancels" mean that those who shall keep books and records stopped keeping electronic ones.
 - 4 "Annulments" mean annuled approvals.
