The filing period of your taxable income in the period of the calendar year 2025, is open;

From February 16 (Mon.) through March 16 (Mon.), 2026

- You are advised that you file your final return and complete the payment <u>before March 16</u>
 (Mon), 2026, if you earn taxable income in the calendar year 2025, from January 1 to
 December 31.
- When you can receive a tax refund, the Tax Office accept your final return **before February 13 (Fri.), 2026.**

- NOTICE -

✓ If you have your Individual Number for Social Security and Tax ("My-Number"), you need to write your number in your return form. You also need to present your identification documents or attach copies of them. (see page 68)

- e. g. 1 Individual Number Card ("My-Number Card")
- e. g. 2 Notification card of the Individual Number and Driver's license or Passport etc.
