4 "Amount of unsettled collection" means the part of amount determined for collection for which receiving, loss through non-payment is not completed.

Note:1 Figures for "Inheritance tax" includes the gift tax.

2 Figures only for National tax agency are shown. Figures for customhouse are not included.
